The Eastern Caribbean Telecommunications Authority (ECTEL) Treaty (Signed 4th May 2000)

5 Contracting States - Grenada, St. Vincent, St. Lucia
Dominica, St. Kitts and Nevis

- **Desirous** of creating a competitive environment for telecommunications in the contracting states
- **Determined** to provide affordable, modern, efficient, competitive and universally available telecommunications services to the people of the contracting states
- **AGREED TO:**
 - Enactment of the ECTEL Treaty** in each member state
 - Formation of the NTRCs** in each member state

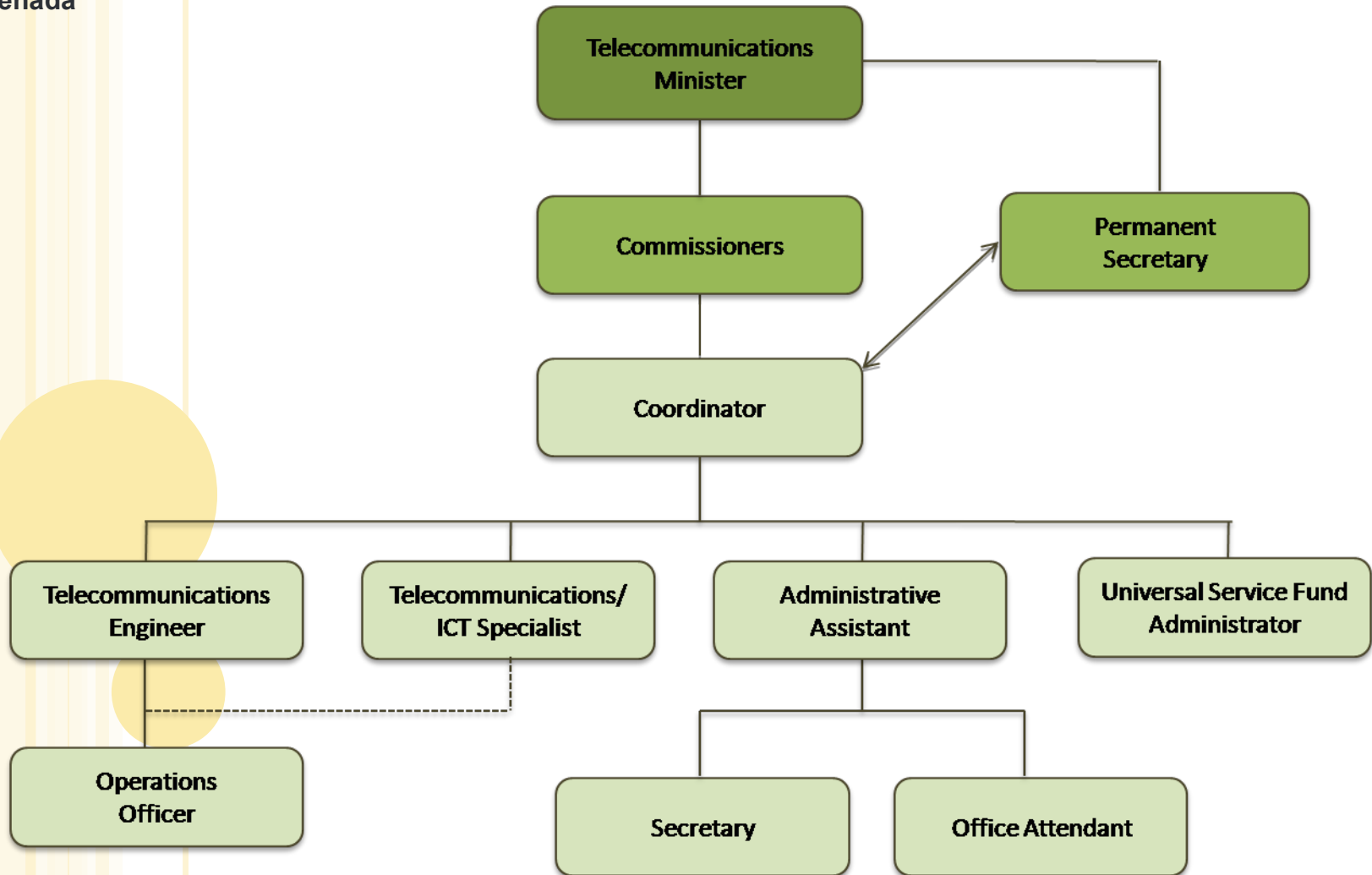

Functions/Powers of the Commission

Regulate prices for telecommunications sector

Review applications

Issue licences and frequency authorisations

Plan, supervise, regulate and manage the use of the radio frequency spectrum in conjunction with ECTEL

Maintain a register of licences and frequency authorisation holders

Collect **all** telecommunications fees

Operate a Universal Service Regime so as to ensure the widest possible access telecommunication access at an affordable rate

Registration and management of internet domain names

Functions/Powers of the Commission

Monitor and ensure compliance with licences

Acquire information – breach of licence, Telecoms Act

Initiate legal proceedings – re compliance with licences

Monitor anti-competitive practices

Investigate and resolve any dispute

Sit as a tribunal

Hold public hearing pertaining to its function

Review proposed interconnection agreement

Manage the Universal Service fund

Consult and liaise with ECTEL
